# Nomination Committee Charter

## Gale Pacific Limited (the Company)

---

### 1. Introduction

#### 1.1 Purpose of Charter

This is the Charter of the Nomination Committee established by the Board of the Company (the **Charter**). The Charter will govern the operations of the Nomination Committee (the **Committee**), if and when formally established by the board of the Company (**Board**). It sets out the Committee's role and responsibilities, composition, structure and membership requirements.

#### 1.2 Role of Committee

The Committee is established by the Board of Directors. The purpose of the Committee is to assist the Board by reviewing and making recommendations to the Board in relation to:

- (a) Board succession issues and planning;
- (b) the appointment and re-election of people as members of the Board and its committees;
- (c) induction of people as Directors and continuing professional development programs for Directors;
- (d) succession plans of the Group Managing Director, senior executives and executive Directors;
- (e) the process for the evaluation of the performance of the Board, its Board Committees and individual Directors;
- (f) the review of the performance of senior executives and members of the Board, which should take place at least annually; and
- (g) the size and composition of the Board and strategies to address Board diversity and the Company's performance in respect of the Company's Diversity Policy, including whether there is any gender or other inappropriate bias in remuneration for Directors, senior executives or other employees.

## 2. Membership

### 2.1 Composition of Committee

The Committee will:

- (a) comprise only of members of the Board of Directors (**Directors**) and members will be appointed and removed by the Board;
- (b) be of sufficient size, independence and technical expertise to discharge its mandate effectively;
- (c) consist of to the extent practicable given the size and composition of the Board from time to time:
  - (i) at least three members;
  - (ii) only non-executive directors;
  - (iii) a majority of independent<sup>1</sup> Directors (**Independent Directors**);and
- (d) an independent chairperson, who will be nominated by the Board from time to time; and
- (e) comprise members who will be appointed for a fixed period of no more than 3 years, with Committee members generally being eligible for re-appointment.

While the Company will aim to have a Committee of at least the size and composition outlined above, this may not always be practicable given the size of the Board and the circumstances of the Company. Accordingly, the Board has absolute discretion to determine the appropriate size and composition of the Committee from time to time.

### 2.2 Ceasing to be a member of the Committee

A person will cease to be a member of the Committee if:

- (a) the person gives reasonable notice in writing to the Committee Chairperson of the person's resignation as a member of the Committee;
- (b) the Committee Chairperson gives the person notice in writing that the person is to cease to be a member of the Committee; or
- (c) the person ceases to be a Director, in which case the person automatically ceases to be a member of the Committee.

### 2.3 Secretary

- (a) The Committee will have a secretary, which is to be the Company Secretary or such other person as nominated by the Board (**Committee Secretary**).
- (b) The Committee Secretary will attend all Committee meetings.
- (c) The Committee Secretary, in conjunction with the Committee Chairperson, must prepare an agenda to be circulated to each Committee member at least 2 full working days prior to each meeting of the Committee.
- (d) The Committee Secretary will distribute a meeting timetable for each forthcoming calendar year.

### **3. Meetings & authority of committee**

#### **3.1 Meetings**

- (a) The Committee will meet as often as necessary, but must meet at least once a year.
- (b) The Committee Chairperson must call a meeting of the Committee if so requested by any Committee member, the Group Managing Director or the Company Secretary.
- (c) The Committee may invite other persons, including internal specialists or external advisers, to attend meetings if considered appropriate by the Chairperson of the Committee.
- (d) The quorum necessary for a meeting of the Committee will be 2 members, of whom at least one must be an Independent Director.

#### **3.2 Authority**

The Board authorises the Committee, within the scope of its responsibilities, to:

- (a) investigate any matter within the ambit of the role of the Committee as described in paragraph 1.2, which is brought to its attention with full access to all books, records and facilities;
- (b) seek any information it requires from an employee (and all employees are directed to co-operate with any request made by the Committee) or external parties;
- (c) obtain outside professional advice as it determines necessary to carry out its duties; and
- (d) ensure the attendance of Company officers at meetings as it thinks appropriate.

### **4. Duties and responsibilities**

#### **4.1 Understanding the Company's Business**

The Committee will ensure it understands the Company's structure, business and controls to ensure that it can adequately assess the significant risks faced by the Company.

#### **4.2 Reporting**

- (a) The Committee Chairperson must report the findings and recommendations of the Committee to the next Board meeting following each meeting of the Committee.
- (b) The minutes of all Committee meetings will be circulated to members of the Board by the Committee Secretary.
- (c) The Committee Chairperson must submit an Annual Report to the Board summarising the Committee's activities during the year and the Committee's significant results and findings.
- (d) The Committee must approve:
  - (i) the details to be published in the Company's Annual Report or any other statutory report or document with respect to the activities and responsibilities of the Committee; and
  - (ii) any statement on the Company's diversity policy and that may be required by law or other regulatory requirements (including any such statement to be included in the Company's Annual Report).

### 4.3 Specific responsibilities

In addition to any other matters which may be delegated to the Committee by the Board (including special investigations), the Committee is responsible for:

#### ***Senior executives and executive Directors succession***

- (a) reviewing succession plans of senior executives and executive Directors on a regular basis to maintain an appropriate balance of skills, experience and expertise in the management of the Company and providing advice to the Board accordingly;

#### ***Board succession***

- (b) reviewing Board succession plans on a regular basis to maintain an appropriate balance of skills, experience and expertise on the Board and providing advice to the Board accordingly;

#### ***New Directors***

- (c) developing policy and procedures for the selection and appointment of Directors;
- (d) identifying individuals who may be qualified to become Directors, having regard to such factors as the Committee considers appropriate, including judgement, skill, diversity, experience with business and other organisations of a comparable size, the interplay of the candidate's experience with the experience of other Board members, the extent to which the candidate would be a desirable addition to the Board and any Board Committee, and the Corporate Governance Principles and Recommendations (3rd edition) of the ASX Corporate Governance Council (the **Guidelines**);
- (e) ensuring that an effective orientation program for new Directors is in place, and regularly reviewing its effectiveness;

#### ***Board Committees***

- (f) identifying Directors qualified to fill vacancies on Board committees and making recommendations to the Board accordingly, having regard to such factors as the Committee considers appropriate, including the terms of reference of the particular Board committee the Director's experience, the interplay of the Director's experience with the experience of other Committee members and the Guidelines;

#### ***Performance***

- (g) developing or arranging a program for inducting new Directors and providing appropriate professional development opportunities for Directors to develop and maintain the skills and knowledge needed to perform their role as directors effectively;
- (h) regularly reviewing whether Directors have the requisite skills, knowledge and familiarity with the Company and its operating environment in order to fulfil their role on the Board;
- (i) in conjunction or collaboration with the Board, developing procedures for the annual evaluation of the performance of the Board, each Board Committee and individual Directors, comparing their performance with the requirements of the Board Charter, this Charter, other relevant Board Committee Charters and the reasonable expectations of individual Directors;

#### ***Senior executives and executive Directors***

- (j) developing and implementing a plan for identifying, assessing and enhancing competencies of senior executives and executive Directors;
- (k) ensuring that the performance of each senior executive and executive Director is evaluated at least annually;

### ***Board***

- (l) considering and articulating the time needed to fulfil the role of Chairperson and non-executive Director;
- (m) developing and implementing a plan for identifying, assessing and enhancing Director competencies;
- (n) establishing procedures for the Committee to oversee the evaluation of the performance of the Board and each Director including an assessment of whether each Director has devoted sufficient time to their duties.

### ***Size and composition of the Board***

- (o) regularly reviewing the size and composition of the Board and making recommendations to the Board with regard to any appropriate changes;
- (p) providing advice to the Board with respect to the necessary and desirable competencies of Directors;
- (q) making recommendations to the Board for the appointment and removal of Directors;
- (r) in a timely manner, making recommendations to the Board whether or not Directors, whose term of office is expiring, should be proposed for re-election at the Company's next AGM;

### ***Diversity***

- (s) developing measurable objectives to achieve gender diversity in accordance with the Company's Diversity Policy;
- (t) monitoring, reviewing and reporting to the Board on the Company's performance in respect of gender diversity in accordance with the Company's Diversity Policy;
- (u) reviewing the Company's Diversity Policy at least annually to assess the effectiveness of the policy and make recommendations to the Board as to any strategies required to address Board diversity;
- (v) reviewing and reporting to the Board at least annually on the relative proportion of women and men at all levels of the business; and
- (w) reviewing and making recommendations to the Board on remuneration by gender.

The Committee will have no executive powers with regard to its findings and recommendations.

## **4.4 Other matters**

- (a) The Committee is authorised to engage, at the Company's expense, outside legal or other professional advice or assistance on any matters within its terms of reference.
- (b) The Committee is authorised to seek any information it requires from any officer or employee of the Company and such officers or employees will be instructed by the Board of the Company employing them to respond to such enquiries.
- (c) No member of the Committee may participate in any decision with respect to his or her position.
- (d) The Committee may, in its discretion, delegate all or some of its responsibilities to a

sub-committee.

#### **4.5 Committee performance**

- (a) The Committee will perform an evaluation of its performance at least annually to determine whether it is functioning effectively by reference to current best practice.
- (b) The Board will evaluate the performance of the Committee as appropriate.

### **5. Other matters**

#### **5.1 Amendment of Charter**

This Charter can only be amended with the approval of the Board.

#### **5.2 Adoption of Charter and periodic review**

This Charter was adopted by the Board on 24 March 2016, and takes effect from that date and replaces any previous charter in this regard.

The Committee must review and reassess this Charter at least annually and, if required, make recommendations to the Board in respect of any amendments to the Charter. The Board will also review this Charter periodically. The Company Secretary will communicate any amendments to employees as appropriate.

## Schedule

### **Independence as defined by the ASX Corporate Governance Council in their Corporate Governance Principles and Recommendations (3rd edition)**

An independent director is a non-executive director who is not a member of management, and who is free of any business or other relationship that could materially interfere with, or could reasonably be perceived to materially interfere with, the independent exercise of their judgment.

The corporate governance guidelines provide certain criteria for assessing the independence of directors and outline relationships which may affect independent status. They provide that when determining the independent status of a director the board should consider whether the director:

1. is, or has been employed in an executive capacity by the company or another group member, and there has not been a period of at least three years between ceasing such employment and serving on the board;
2. is, or has within the last three years been, a principal, partner, director or senior employee of a material professional adviser or a material consultant to the company or another group member;
3. is, or has been within the last three years, in a material business relationship (such as a supplier or customer) with the company or other group member, or an officer of, or otherwise associated directly or indirectly with, someone with such a relationship;
4. is a substantial shareholder of the company or an officer of, or otherwise associated directly with, a substantial shareholder of the company;
5. has a material contractual relationship with the company or another group member other than as a director of the company;
6. has close family ties with a person who falls within any of the above categories; or
7. has been a director of the Company for such a period that his or her independence may have been compromised.

Family ties and cross-directorships may be relevant in considering interests and relationships which may compromise independence, and should be disclosed by directors to the board.
