# Management Restructure Director Appointment and Resignation – Appendices 3X and 3Z

As announced by Gale Pacific Limited (**Gale** or the **Company**) in its Appendix 4E dated 25 August 2014, the Company is undertaking a major organisational restructure, pursuant to which Mr Nick Pritchard, currently Managing Director of the Australasian business, has been appointed Group Managing Director, effective 22 August 2014.
